## BIN TIPS

Dear Residents,

**Please keep the bin area neat and tidy** – Let us know if you see anyone leaving the bin area in a state you are unhappy with.

**Plastic, paper, metals and packaging go in the green bins** – No glass or batteries though, these go to a bring centre or bottle bank. Bring unwanted clothes to a charity shop.

**Only put organic waste in the brown bins** – Anything that rots like food or garden waste.

**Try to recycle as much as you can** – Almost everything can be recycled and the environment will thank you for it.

**Make sure you don't take in our neighbours bins!** – And keep an eye out for our neighbours taking in your bins.

## Dear Householder,

You are receiving a **140 litre Brown Bin** today for **food waste** (including cooked and raw meat and fish, vegetables and fruit peelings, rice, pasta, bread and teabags) and **garden waste** (such as grass, weeds and hedge clippings).

Using your Brown Bin can reduce the amount of waste in your Black Bin by **25-30%**.

- See enclosed calendar for details of both your **Black** and **Brown Bin** collection for the coming months. You can also download it from [www.sdcc.ie](http://www.sdcc.ie).
- When your Brown Bin collection starts the Black Bin collection will move to every two weeks; there will be a Black Bin collection one week, Brown Bin the following week, and so on. Enclosed is your bin calendar.
- Collection of the Brown Bin (140 litre) will be half the cost (50%) of the Large (240 litre) Black Bin
- Householders with a waiver will be automatically credited with a number of bin lifts quarterly, allocated between the Black and Brown Bins.
- For hygiene reasons we encourage you to put the Brown Bin out for collection every two weeks. Please wrap food waste in newspaper and **do not** put plastic bags into the Brown Bin.
- The Waste Bye-laws for South Dublin County will mean that householders must take a Brown Bin when one is delivered.



## What can I put in my **brown bin**?

### **NO** Waste Not Allowed in your Brown Bin

- ~~✗~~ Plastics of any kind
- ~~✗~~ Metal of any kind
- ~~✗~~ Glass or crockery
- ~~✗~~ Tin foil, sweet or crisp wrappers
- ~~✗~~ Milk or juice cartons
- ~~✗~~ Batteries, oils, lights, electrical goods, furniture, shoes or clothes
- ~~✗~~ Nappies
- ~~✗~~ Ashes, coal, rocks, gravel, stones, clay and stumps
- ~~✗~~ Weed killer
- ~~✗~~ Glossy paper or magazines
- ~~✗~~ Dog or cat litter

Dear Residents,

**It is a requirement of all residents to use the green recycling bins provided** – Let us know if you see anyone leaving recyclables in the black bins.

**Batteries, clothes and glass go to the nearest battery / clothes / bottle bank** – The environment will thank you for it.

**Report anyone leaving waste bags anywhere other than in the relevant bins** – Let us know if you see anyone leaving waste bags on the ground or the bin area in a state you are unhappy with.

**A charge of €35+VAT is applied to any resident not recycling** – Applied where WMS staff re-sort recyclables or where bags are left outside bins.
